This form commits you to a professional course where all Educators work according to a specific guideline and standards, set by myself, Yolande Bekker (owner of Young Nails Africa). For us it is important to help you to build a career and to be successful. Without your co-operation we cannot reach that standard.

THE RESPONSIBILITY OF THE EDUCATOR

The Educator will teach and assist you in acquiring new techniques and help you to improve on existing techniques.
No Educator will deviate from the set standards and are therefor under no obligation to pass a student who is not up to standard or did not complete or pass the course successfully. The Educator has the right to inform students to stay longer for extra help.
The Educator will assist with any problems or issues the student may have.

THE RESPONSIBILITY OF THE STUDENT

The student will respect the property, rules and regulations of the Educator and their property.
The student will pay attention in class and take additional notes, without the Educator instructing to do so.
The student must ask for help if unsure.
The student must prepare for theory examinations.
The student must attend class and follow all instructions, given by the Educator.
The student has 2 months to hand in any assignments. If the relevant assignments have not been handed in, then no Certificates will be issued. (Assignments will be explained during the course)
The student must adhere to the scheduled theory and practical examination dates. Only a valid doctors note or death certificate will be accepted as a valid excuse. The student must inform the Educator if the student cannot attend class.
The student will be liable to attend the Educators next class should the student miss a class or needs to catch up on lost work.
The Educator may charge for extra days if applicable.
The student must be committed to the course and it is the student's responsibility to be successful. (With the help of the Educator)
The student must complete the entire course and exams within 3 months of the chosen course start date. The student will have to attend a refresher course should the student not comply with this. New exam dates must be arranged with the Educator within 3 months of the initial course date, should the student not attend the initial set out practical exam dates. The student will have to start with a new course with full fees payable, if the student did not complete the practical exams with 6 months of the start date of initial enrolment. The onus lies with the student to arrange with the Educator for new practical or theory exam dates. The students file will be closed at Head Office if the student did not complete their practical exams within 6 months.

I understand that the Educator will not contact me should I miss any examinations and that it stays the responsibility of the student to make any alternative arrangements for whatever reason.

The student is responsible to contact the Educator or Head Office for any results that was not given during the course.

EXTRA CHARGES

Pass rate for all theory examinations are 80%. The student will receive enough time to prepare for these tests. Should you not pass a theory examination, there will be a re-write exam available. Pass rate for all practical examinations are 85%. Should you not adhere to the scheduled practical examination date, you will have to pay R250 per practical examination before the examination starts. All Educators will inform you about the scheduled examinations.

Students who have completed their course and adhered to the scheduled practical examination dates, will not be liable for any additional charges. All courses have scheduled dates and student have to adhere to these dates.

Should you not finish your course during the extended period, an additional charge of R450 per day must be paid to the Educator until you have completed the course.

Should a student reschedule practical examinations without a doctors note or a valid excuse like illness or death, the student will have to pay R250 per system
